Matildas childcare case fails

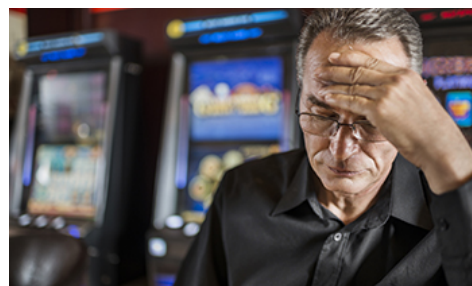
